- Amber Mixon will be contact and check on 25 Disney on Ice tickets for "Into the Magic" on Sunday, December 22nd at noon. Text or email Amber; has no cell phone access during working hours at RSU1. Limit 5 tickets.
- FREE Family Game Night this winter. Will try February 19th, 5-7PM. Need advance notice because we provide pizza (& could provide cocoa) for families during Game Night.
